WMI has a Compensation Plan second to none, beginning at m1 where you start as a Master consultant and receive \$1000 profit on your very first m1 sale. m2 and m3 has two Consultant Positions or titles, Consultant and Master Consultant. Our consultants get paid directly by the new Members and profit on the very first sale as an m1 Master Consultant! Every m2 and m3 sale you make moves you closer to a rank promotion of Master Consultant. **All m3 payments are paid directly to the company.**

By taking advantage of the Platinum Plus program (combination of m<sup>1</sup>, m<sup>2</sup> and m<sup>3</sup>) you will be promoted to a Master Consultant for the m<sup>2</sup> and m<sup>3</sup> programs.

**Chart Five: Compensation for “Platinum Plus Program” Sales – Combined m<sup>1</sup>, m<sup>2</sup>, and m<sup>3</sup> Programs**

When you purchase the “Platinum Plus” Program you will be immediately promoted to the higher paying position of Master Consultant for the m<sup>1</sup>, m<sup>2</sup>, and m<sup>3</sup> Programs!

**Important Notes**

- You must be an m1, m2, or m3 Consultant to be compensated as an m1, m2, or m3 sale. In other words, you must first be a consultant at a particular level to be eligible to receive commissions and residual income checks for that particular Consultant level. Example: If you are an “m1 Consultant” and someone joins your organization (via your consultant number) as an “m2 Member or Consultant”, you would only be paid commissions on the “m1 portion” of the sale. In this case, the next Sponsoring Consultant above you that is currently an “m2 Consultant” would instead be paid this commission. The same process applies to m3 Memberships. In these situations, only the sale itself is passed up, not the person. Once you gain Membership at that particular level you would gain the right to earn both commissions and residual income for that level.
- Sponsoring Consultant must maintain either one m1, m2 or m3 sale in the month to qualify to receive Infinity Bonus and or Sponsoring Consultant commissions. m3 is an annual membership.

- Consultants will have 2 grace months per year, where 1 qualifying sale is not necessary. This is based on calendar year from date of sign up.
- If a Consultant has not had an m1, m2, or m3 personal sale for a period of six consecutive calendar months (and thus become “inactive”), his or her team may be permanently moved to another Consultant.
- Any Consultants or Member that gets started as an m1 Consultant or m1 Member has 20 days from the time they entered their m1 order to take advantage of the “Platinum” and or “Platinum Plus” programs. Consultants taking advantage of the “Platinum” or “Platinum Plus” programs will receive approximately a 10% discount on the combined pricing, but more importantly be promoted to the status of “Master Consultant” for the m2 and m3 programs. This means full payout immediately on the WMI product line.
- You are not required to purchase the m1, m2 or m3 to become a Consultant with WMI. If you choose, you may pay an annual \$99 Consultant Fee and begin marketing with WMI, which will also include your own Replicated Virtual Office Web Site. If this option is selected however, the Consultant will also be required to make a total of three (3) referred sales to his/her Sponsoring Consultant. In this scenario, both the money and the new Consultant will be given to the Sponsoring Consultant. Following the third referral, the Consultant is now “qualified” and enters the WMI Compensation Plan as an “m1 Consultant”.
- WMI has provided each Consultant with the best marketing tools and web site possible. Through the back office you will be able to manage all leads, run reports to distinguish best lead sources, keep stats on your team progress and much more. As a new m1, m2 and or m3 consultant with Wealth Masters, you will pay a one time set up fee of \$99 for your self replicated web site and back office Business Center. After 30 days your card will be charged \$49.95 a month to maintain the services. Once a WMI Consultant signs the online Consultant Agreement, there are no refunds on the product purchase (m1, m2 or m3.) m1 Members have a 10 day grace period in which they can return the m1 in the same condition as when they received it for a full refund. There are no refunds on m2 or m3 for Member or Consultants.
- **Additional Payout Bonus for the Wealth Acceleration Program:** For each client that goes through the Wealth Acceleration Program (WAP), Certified Consultants will be paid .50% on the amount of interest saved for clients; for example: A saving of \$200,000 of interest will pay a Certified Consultant \$1,000.00. These commissions will be paid out to Consultants after the closing of the WAP Program.
- WMI Consultants also receive a \$500 credit for each m2 repeat ticket sold to their frontline Consultants. This is paid in the form of a credit which can be applied towards the purchase of any WMI products. M1, m2 repeat tickets etc. Proper documentation needs to be completed by the Consultant in the timeframe determined by the company following the m2 conference. In order for the Consultant to receive the credit, they must also be in attendance at the m2 conference.
